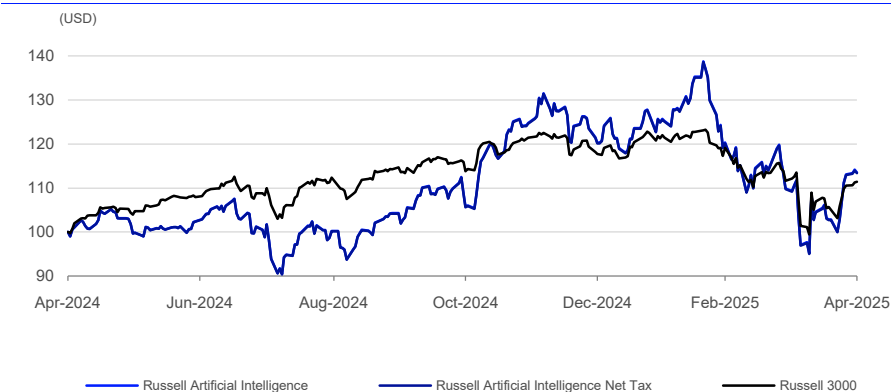


Russell Artificial Intelligence Index (Chinese)
