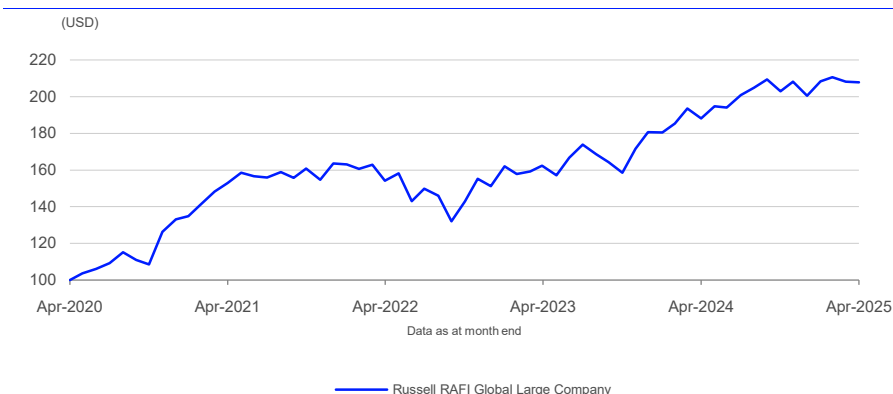


Russell RAFI™ Global Large Company Index
