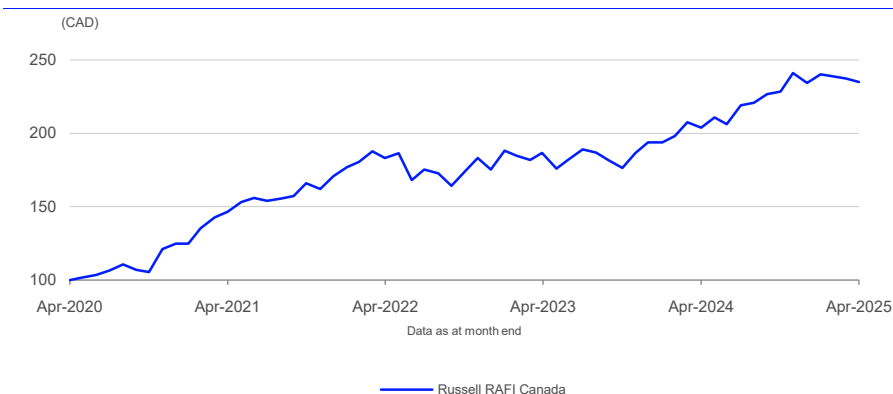


Russell RAFI™ Canada Index
