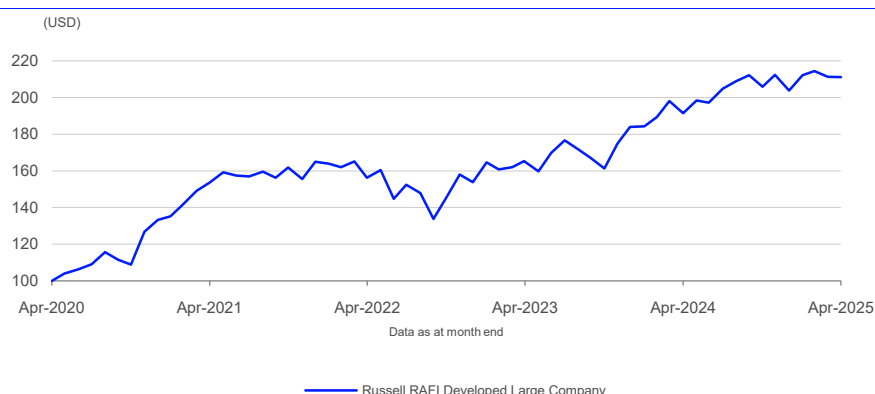


Russell RAFI™ Developed Large Company Index
