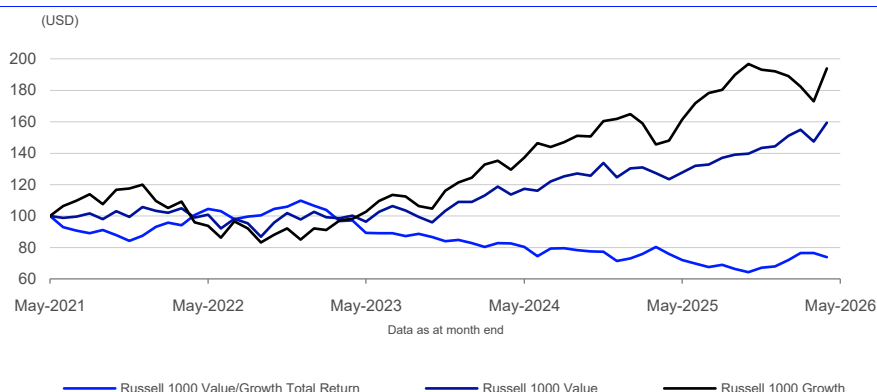


Russell 1000[®] Value / Growth (Long/Short) Indexes

The Russell 1000 Value / Growth Index measures the relative performance of a combination of their component indexes, the Russell 1000 Value Index and the Russell 1000 Growth Index and a cash component. The Russell 1000 Value / Growth Index represents a positive weighting on the Russell 1000 Value Index and a negative weighting on the Russell 1000 Growth Index. The weight for both component indexes will be reset to (+/-) 100% on a daily basis with no cost of borrowing or margin requirement and no interest on cash. The Russell 1000 Value / Growth Indexes is designed to provide a benchmark for market participants looking to measure the relative performance of a value compared with growth investment theme.
