

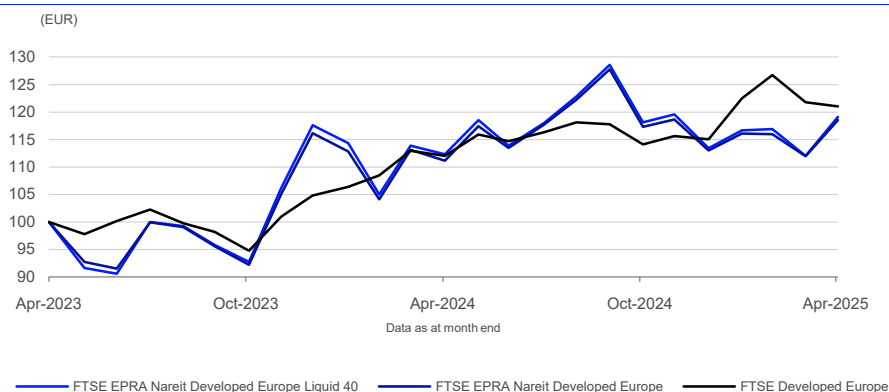
FTSE EPRA Nareit Developed Europe Liquid 40 Index

The FTSE EPRA Nareit Global Real Estate Index Series is designed to represent general trends in eligible real estate equities worldwide. Relevant activities are defined as the ownership, trading and development of income-producing real estate. The index series now covers Global, Developed and Emerging indices, as well the UK's AIM market.

The underlying universe for the FTSE EPRA Nareit Developed Europe Liquid 40 Index is the FTSE EPRA Nareit Developed Europe Index. The index consists of the 40 stocks with the highest volume traded and/or market capitalisation within the FTSE EPRA Nareit Developed Europe Index and is designed to track the performance of listed real estate companies and REITS. By making the index constituents free-float adjusted, liquidity, size and revenue screened, the series is suitable for use as the basis for investment products, such as derivatives and Exchange Traded Funds (ETFs).

Coverage

The EPRA Nareit Developed Europe Liquid 40 Index consists of the 40 stocks with the highest volume traded and/or market capitalisation within the FTSE EPRA Nareit Developed Europe Index and is designed to track the performance of listed real estate companies and REITS.

Diversified Investment Opportunities

The index series provides investors with the diversification that real estate offers due to its low correlation with other asset classes, along with sufficient liquidity to gain access to the asset class.

Objective

The indexes are designed for the creation of index tracking funds, derivatives and as a performance benchmark.

Investability

Stocks are selected and weighted to ensure that the index is investable.

Liquidity

Stocks are screened to ensure that the index is tradable.

Transparency

The index uses a transparent, rules-based construction process. Index Methodologies are freely available on the FTSE Russell website.

Availability

The index is calculated based on price and total return methodologies, both real time and end-of-day. A Net Total Return index is also calculated.

Property Sector Classification

Constituents are classified into distinct Property Sectors based on gross invested book assets as disclosed in the latest published financial statement.
