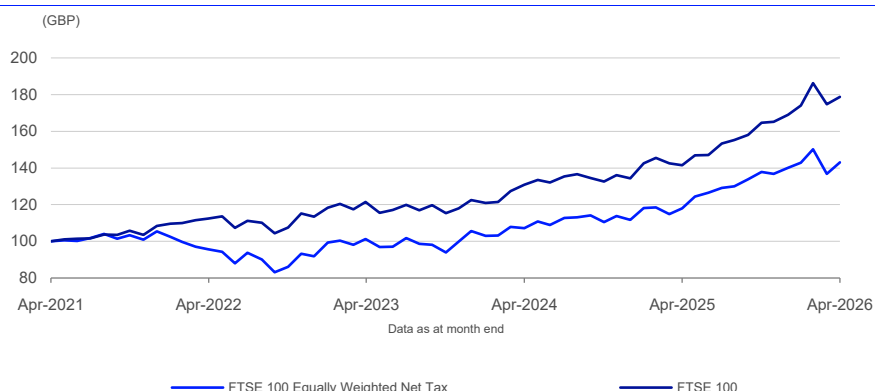


FTSE 100 Equally Weighted Index

The FTSE 100 Equally Weighted Index is an equally weighted version of the FTSE 100 Net Index. The index will contain the same constituents as the cap weighted FTSE 100 Index, however, each company is given an equal weighting in the FTSE 100 Equally Weighted Index at the quarterly rebalance.

FEATURES

Coverage

The index contains the same constituents as the FTSE 100 Index, with each company allocated a weight of 1%, rebalanced quarterly.

Objective

The index is designed for use in the creation of index tracking funds, derivatives and as a performance benchmark.

Liquidity

Stocks are screened to ensure that the index is tradable.

Transparency

The index uses a transparent, rules-based construction process. Index Rules are freely available on the FTSE website.

Availability

The index is calculated based on price and net total return methodologies, both real time intra-second ticks and end-of-day.

Industry Classification Benchmark

Index constituents are categorized in accordance with the Industry Classification Benchmark (ICB), the global standard for industry sector analysis.
