

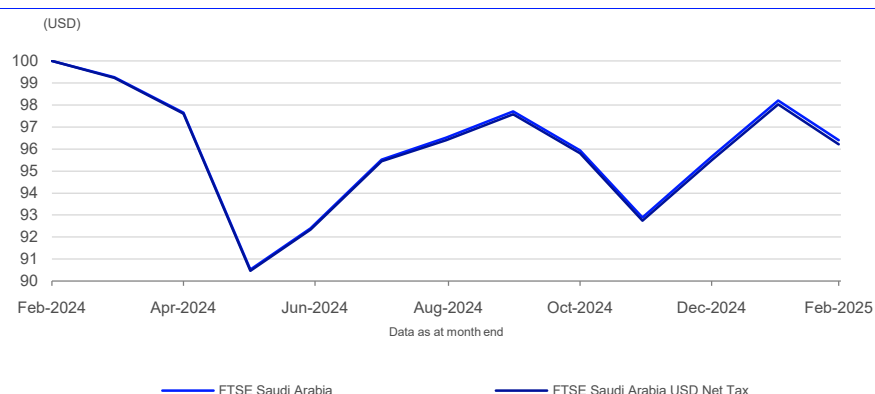
FTSE Saudi Arabia Index (USD)

The FTSE Saudi Arabia Index is a market-capitalization weighted index representing the performance of large and mid-cap Saudi Arabian companies that are constituents of the FTSE All-World Index.

Stocks are screened to ensure that the index is tradable.

Availability

The index is calculated based on price and total return methodologies, both real time and end of day.

Index constituents are categorized in accordance with the Industry Classification Benchmark (ICB), the global standard for industry sector analysis.
