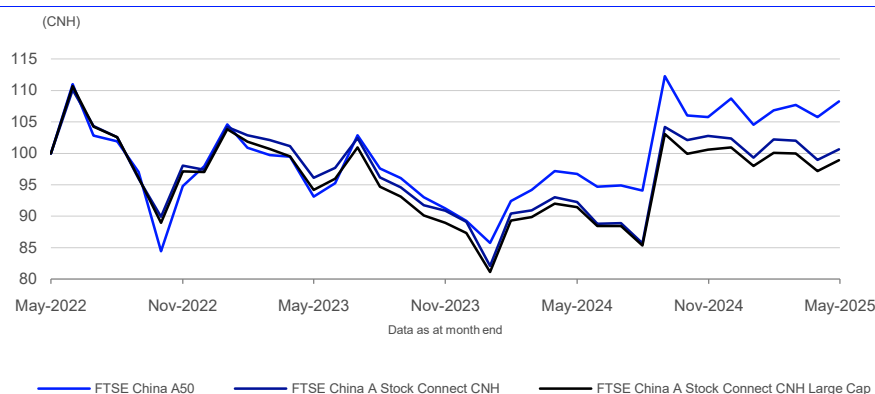


FTSE China A50 Index (Traditional Chinese)

富時中國 A50 指數是由 50 家最大 A 股公司組成的實時可交易指數。A 股是中國大陸註冊成立的公司於上海或深圳證券交易所上市、以人民幣報價交易的證券。該指數為中國 A 股市場提供代表性和可交易性的最佳平衡。指數成分股須符合外國擁有權限制（從 2022 年 3 月的季度審核開始實施），並須符合北向滬深港通計劃的資格（從 2022 年 6 月的季度審核開始實施）。該指數以秒內流式更新發佈，為投資者提供最快、最新的中國 A 股市場數據資訊，以便對市場事件做出更迅速的反應。
