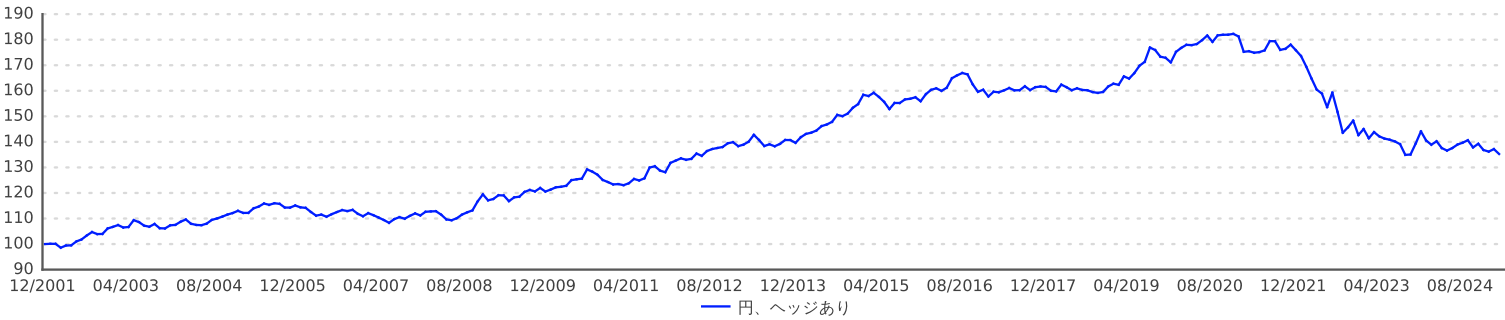
FTSE アドバンスト気候世界国債インデックス (除く日本、国内投信用) (アドバンスト気候 WGBI ex 日本 JIT) は、FTSE 世界国債インデックス (国内投信用) (WGBI-JIT) に含まれる日本以外のセグメントの債券のパフォーマンスを測定します。その際に個別の定量的気候関連ビラー 3 本 (移行リスク・物理的リスク・耐性) を測定した各国の相対的な気候リスクパフォーマンスに応じてインデックスのウェイト調整を行うティルト手法を採用します。
