主权债 | 多币种

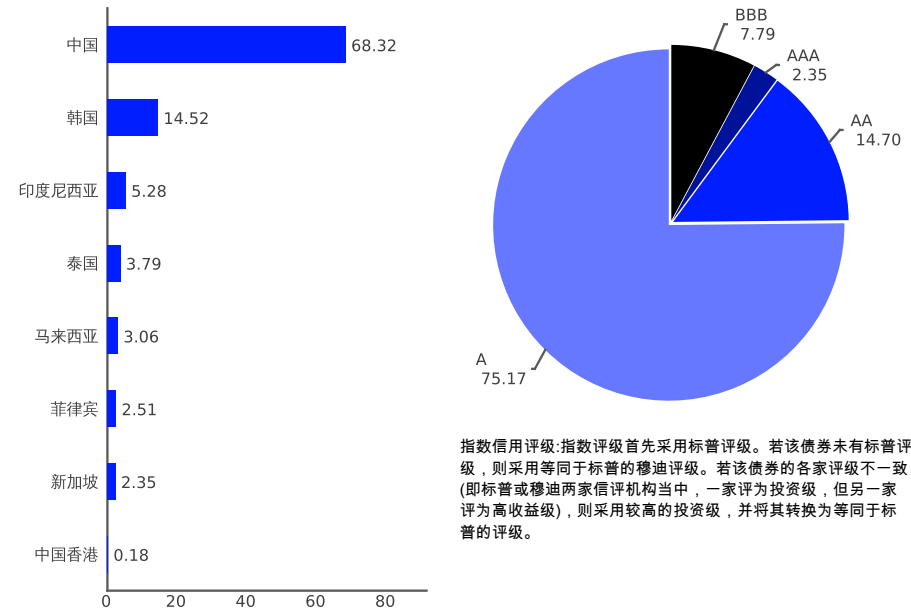
亚洲国债指数 (AGBI)由亚洲本币主权债所构成，旨在为资产管理机构提供一个衡量该市场表现的绩效指标。为方便投资人在相同的基准上比较各国主权债的表现，AGBI的编制规则与计算方法与世界国债指数 (WGBI)一致。我们也提供由不同货币，年期或信用评级所组成的子指数系列。

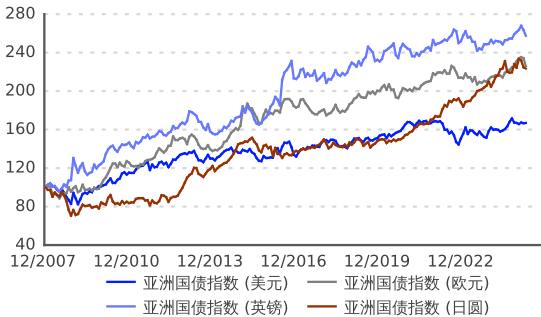
