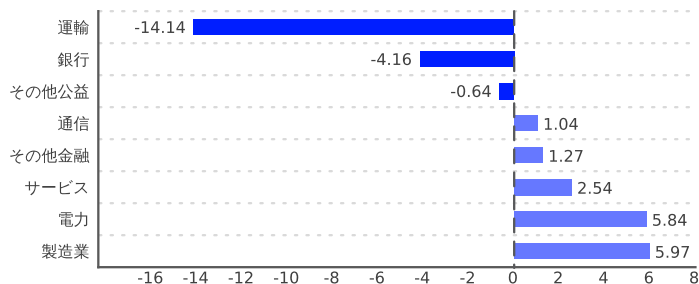

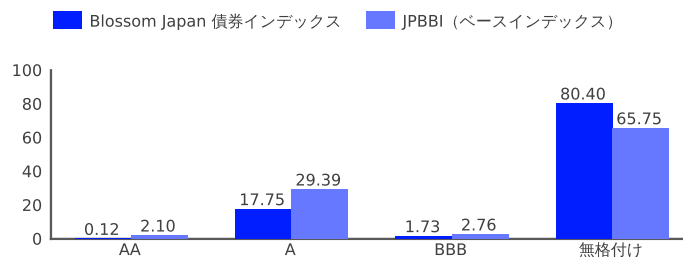

時価総額比較 (単位%)

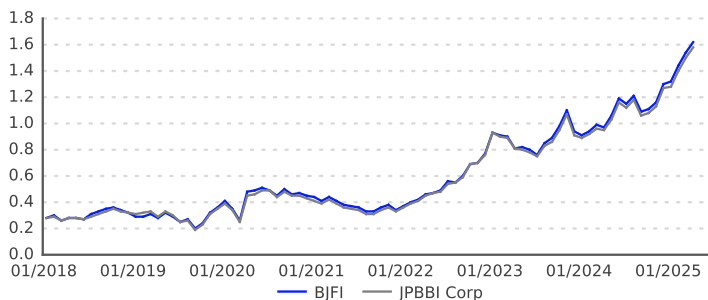
上位オーバーウェイトおよびアンダーウェイト (BJFI) - (JPBBI社債)



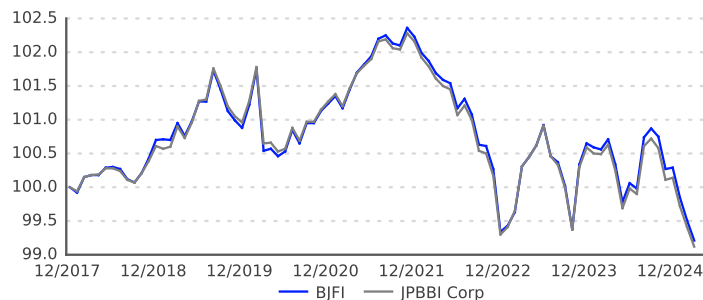
信用格付 (単位%, S&P/Moody's による投資適格格付け)
