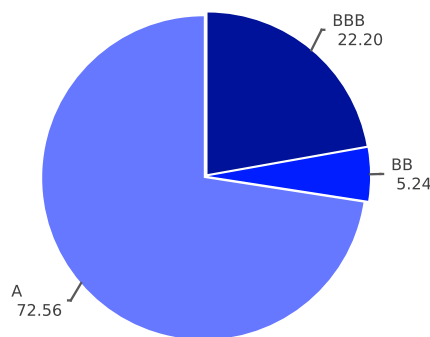
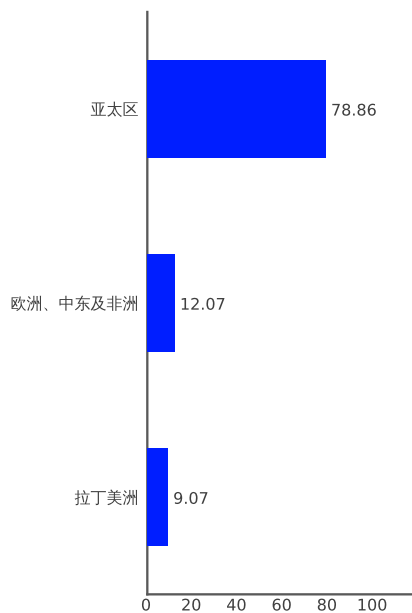
新兴市场国债指数 (EMGBI) 由16个国家所发行的本币主权债所构成, 旨在为投资经理人提供一个衡量新兴市场国债表现的广泛绩效指标。为方便投资人在相同的基准上比较各国主权债的表现, EMGBI的编制规则与计算方法与世界国债指数 (WGBI) 一致。我们也提供由不同货币, 年期或信用评级所组成的子指数系列。

市场及评级分布 (市值权重 %)



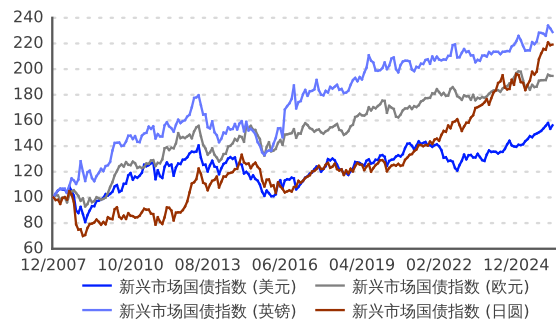
