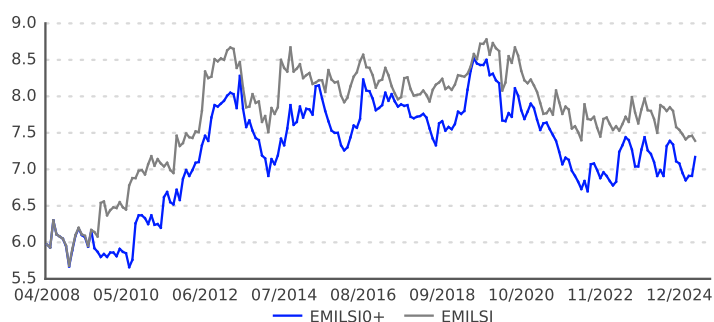
The FTSE Emerging Markets Inflation-Linked Securities 0+ Years Index (EMILSI0+) tracks the universe of securities that meet the eligibility criteria for the flagship FTSE Emerging Markets Inflation-Linked Securities Index (EMILSI) through to maturity. The EMILSI measures the performance of inflation-linked bonds with fixed-rate coupon payments that are linked to an inflation index. The EMILSI covers debt from seven countries denominated in seven currencies and can be used as a benchmark for investors who are concerned with real, rather than notional, returns. Sub-indices are available in any combination of currency, maturity, and rating.

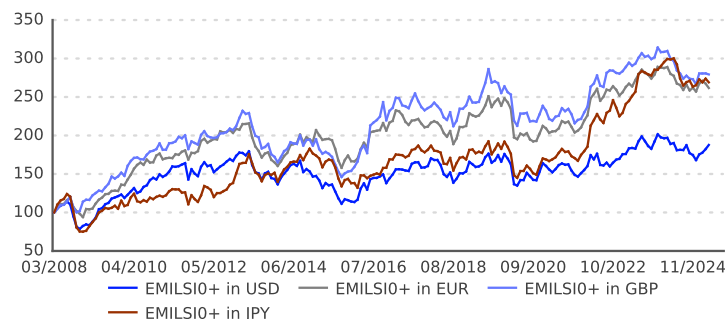
Real Yield Duration
