## About the index

FTSE Russell has partnered with Digital Asset Research (DAR) to extensively cover the digital asset market via our FTSE Digital Asset Index Series. Representing one of the more than 400 covered assets, the FTSE Solana Index (1700 CET) reflects the settlement price of Solana as determined by the FTSE DAR Reference Price Methodology. The index was designed to meet the requirements of EU BMR and UK BMR. FTSE is the Benchmark Administrator of the index.

The FTSE Single Digital Asset Index Series leverages the FTSE DAR Reference Price. The underlying price employs a methodology designed to capture high quality data from digital assets exchanges vetted for governance, regulatory compliance, and technical capabilities.

The index is published in USD and calculated hourly between Sunday and Friday. The index is published daily at 1700 CET.

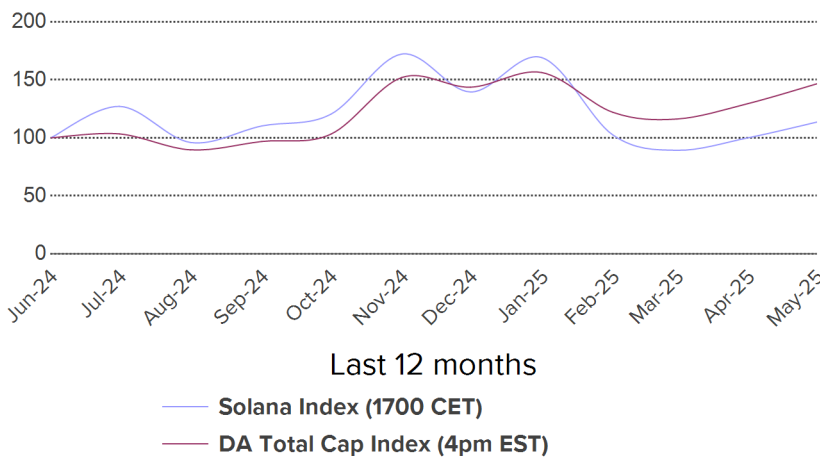
