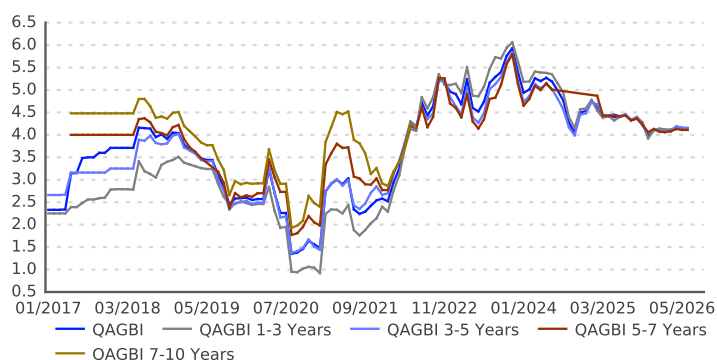

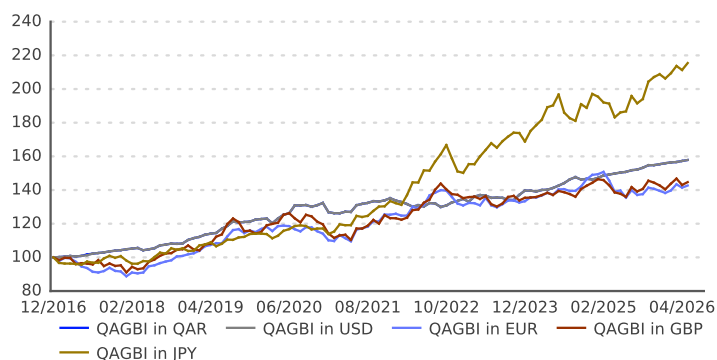

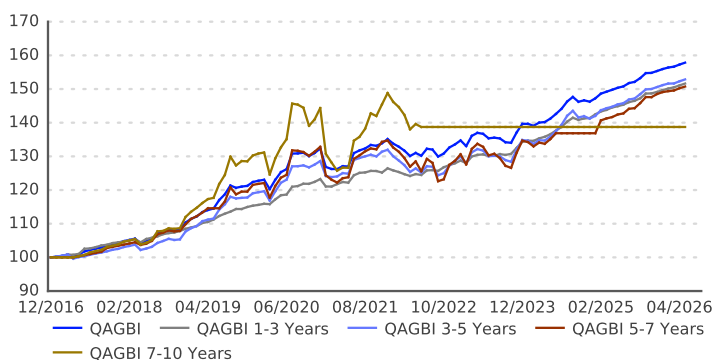
## HISTORICAL YIELD TO MATURITY
