

# Russell Small Cap Completeness Value Index

## About the index

The Russell Small Cap Completeness® Value Index measures the performance of the Russell 3000® Index companies excluding S&P 500 constituents. It includes those Russell Small Cap Completeness Index companies with relatively lower price-to-book ratios, lower I/B/E/S forecast medium term (2 year) growth and lower sales per share historical growth (5 years). The Russell Small Cap Completeness Value Index is constructed to provide a comprehensive and unbiased barometer for the extended broad value market beyond the S&P 500. The Index is completely reconstituted annually to ensure new and growing equities are included and that the represented companies continue to reflect value characteristics.




