About the index

The Russell Top 200® Growth-Dynamic Index® measures the performance of the especially large cap segment of the US equity universe that exhibit growth-dynamic characteristics. It includes Russell Top 200 Index companies with relatively higher price-to-book ratios, higher I/B/E/S forecast medium term (2 year) growth and higher sales per share historical growth (5 years) and relatively less stable business conditions which are more sensitive to economic cycles, credit cycles, and market volatility based on their stability variables: volatility (price and EPS), leverage, and ROA. The Russell Top 200 Growth-Dynamic Index is constructed to provide a comprehensive, unbiased, stable barometer of this larger cap growth-dynamic market. The Index is completely reconstituted annually to ensure new and growing equities are included and that the represented companies continue to reflect growth and dynamic characteristics.




