The index includes the smallest 1,000 companies in the small cap Russell 2000® Index, plus up to the next 1,000 smallest eligible companies included in the Russell 3000E™ Index. The Russell Microcap Index is constructed to provide a comprehensive and unbiased barometer of US micro cap equity performance. Semi-annual reconstitution and quarterly IPO inclusions ensure newly eligible companies are represented and that larger stocks do not distort the performance and characteristics of this investable US micro cap opportunity set.

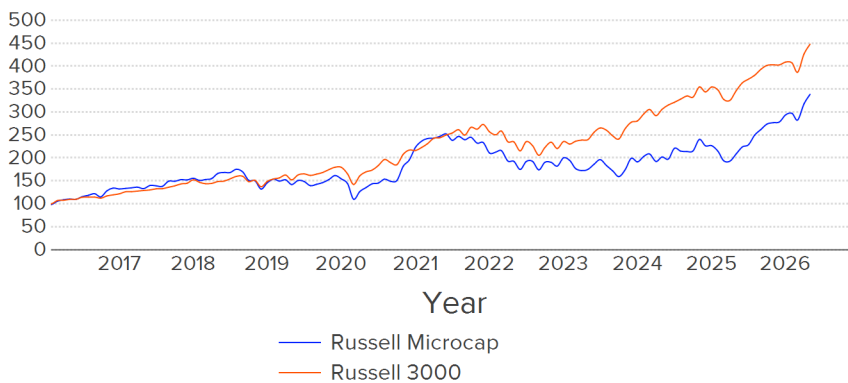

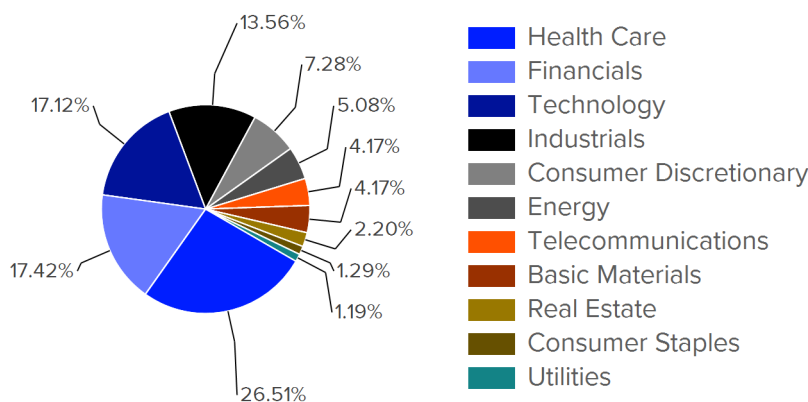
