


# FTSE Eurozone Oil & Gas Select 50 Point Decrement Index III

The FTSE Eurozone Oil & Gas Select 50 Point Decrement Index III is designed to reflect the performance of mid and large cap Eurozone companies with the largest investable market capitalisations, as defined within the FTSE Eurozone Index and categorized as Oil & Gas in the ICB classification framework. The FTSE Eurozone Oil & Gas Select 50 Point Decrement Index III replicates an investment in the FTSE Eurozone Oil & Gas Index with a decrement of 50 index points per annum, accruing on a daily basis.
