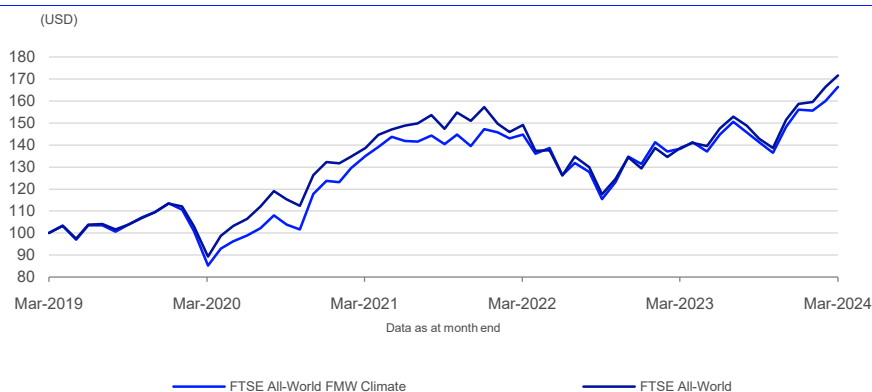


# FTSE All-World FMW Climate Index

Data as at: 29 March 2024

The FTSE All-World FMW Climate Index is designed to reflect the performance of securities weighted by a set of accounting measure of size. The index additionally incorporates three key climate change considerations. Climate change considerations are captured via reductions in carbon emissions and fossil fuel reserves and increased levels of green revenues as detailed in FTSE Global Climate Index Series Ground Rules. The universe is screened for nationality, free float, liquidity and multiple line rules according to the FTSE Global Equity Index Series Ground Rules.

### Objective

The indexes are designed for the creation of index tracking funds, derivatives and as a performance benchmark.

### Investability

Stocks in the underlying universe are free-float weighted to ensure that only the investable opportunity set is included.

### Liquidity

Stocks in the underlying universe are screened to ensure that the index is tradable.

### Transparency

The index uses a transparent, rules-based construction process. Index methodologies are freely available on the FTSE Russell website.

### Availability

The indexes are calculated based on price and total return methodologies, and available end-of-day.

### Industry Classification Benchmark (ICB)

Index constituents are categorized in accordance with the Industry Classification Benchmark (ICB), the global standard for industry sector analysis.
