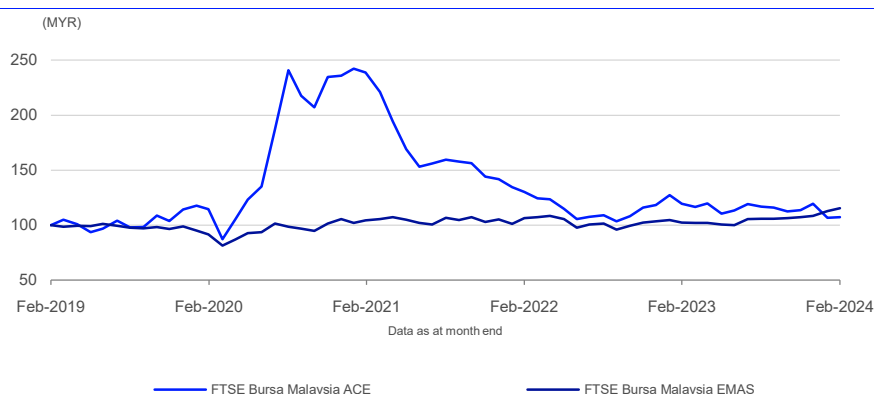
The FTSE Bursa Malaysia ACE Index has been designed to provide investors with access to stocks listed on the ACE Market in Malaysia.
