Index rules are freely available on the FTSE Russell website.

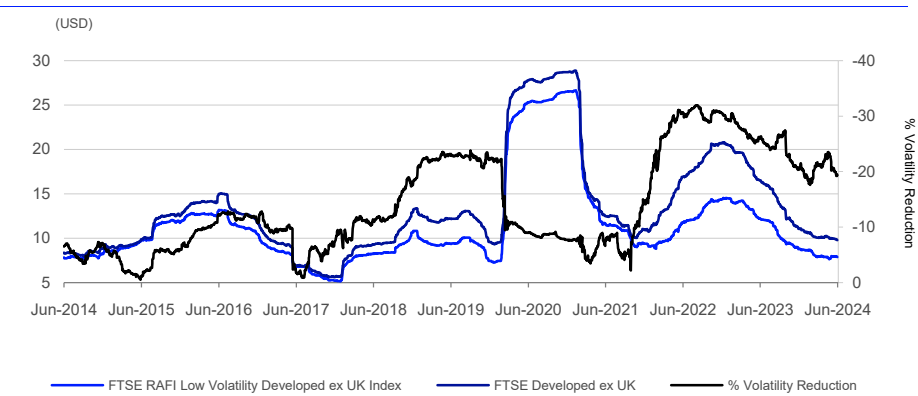
Availability
