

FTSE US Broad Investment-Grade Impact Bond Index

Multi-Sector | US Dollar

The FTSE US Broad Investment-Grade Impact Bond Index (USBIG Impact) constituents are selected from the FTSE US Broad Investment-Grade Bond Index (USBIG), screened in accordance with the transparent and defined green, social and sustainability (GSS) bond criteria.

The USBIG Impact leverages Refinitiv data and Climate Bonds Initiative (CBI) data to identify underlying bonds that are in compliance with corresponding international guidelines. Specifically, CBI data is used to identify eligible Green Bonds whose use of proceeds are in line with the Paris Agreement. Refinitiv data identifies eligible Social and Sustainability Bonds that are in line with the core components of International Capital Markets Association (ICMA) Social Bond Principles (SBP) and/or ICMA Sustainability Bond Guidelines (SBG).

The USBIG Impact is a multi-sector GSS bond benchmark of investment-grade, US Dollar denominated debt issued by US Treasury, government-sponsored, and corporations.


HISTORICAL EFFECTIVE DURATION
