Further to the technical notices published on **10 May 2023** and **24 May 2023**, FTSE Russell would like to inform index users of the following updates to certain indices within the **FTSE Global Choice Index Series** which will be implemented at the **March 2024 index review**.

Effective in conjunction with the March 2024 index review, **companies classified in ICB Subsector 65102020 - Gas Distribution will be ineligible for inclusion from the below indices.**
