

FTSE Canada Bond Index - Sector Classification of TCHC Issuer Trust & First Nations Fin. Auth. Bonds

FTSE Russell has reviewed the sector assignment for bonds issued by TCHC Issuer Trust and First Nations Fin. Auth within the FTSE Canada Bond Indices. The sector for TCHC Issuer Trust will be updated from Government – Provincial – Ontario to **Government – Municipal – Ontario** and the sector for First Nations Fin. Auth will be updated from Government – Municipal – British Columbia to **Government – Federal – Agency**.

Currently, 2 bonds (CAD 450 million in amount outstanding) issued by TCHC Issuer Trust and 4 bonds (CAD 1.73 billion in amount outstanding) issued by First Nations Fin. Auth are eligible for the FTSE Canada Universe Bond Index, representing 0.02% and 0.08% respectively of the index on a market value weighted basis. Additionally, the First Nations Fin. Auth (32117DAA2) (CAD 249 million in amount outstanding) is eligible for the FTSE Canada 0-1 Universe Bond Index, representing 0.01% of the index on a market value weighted basis. The change in sector assignment will be applied on May 13, 2024 for these bonds. Any newly issued securities will have the updated classification assigned to them.
