

FTSE advises that the price for 18 February 2015 of Ormat Industries Ltd (Israel, 6664251) will be updated to reflect the official closing price of Ormat Technologies Inc. (USA, B03L311) adjusted by the merger terms.

The WM/Reuters 4pm Closing Spot Rates for 18 February 2015 will be used to convert the adjusted price of Ormat Industries Ltd (Israel, 6664251) to Israeli New Agorot.

This applies to all FTSE indices of which Ormat Industries Ltd (Israel, 6664251) is a constituent. All other details remain unchanged.
