

## Altice SA (Netherlands): Reorganisation Changes in FTSE Indices

Subject to the completion of the reorganisation of Altice SA (Netherlands, constituent) into Altice NV A (Netherlands) and Altice NV B (Netherlands), FTSE announces the following changes:
