*Please note: In relation to the Compagnie Financiere Richemont AG share conversion ratio of 1 Compagnie Financiere Richemont AG 'A' share for every 10 Depositary Receipts held, the shares in calculation of Compagnie Financiere Richemont AG will decrease by a factor of 10 from start of trading 19 April. Compagnie Financiere Richemont AG's close price of 18 April will concurrently be increased by a factor of 10 from start of trading 19 April. The application of the conversion in FTSE/JSE indices should therefore maintain market cap neutrality as previously outlined in the informative notice.

Please also note Compagnie Financiere Richemont AG 'A' shares will be treated as foreign for index purposes and will use SWIX free float in all the indices from the June 2023 review.
