\*Further to the notice published on 05/02/2025, **Coca-Cola Europacific Partners**, has had its nationality re-assessed and will change nationality status from US to UK.

**CRH** and **Flutter Entertainment** have had their nationality re-assessed under rule 1.9 of the Determining Nationality guide, CRH and Flutter Entertainment will change nationality status from UK to US.

Atalaya Mining Copper, has been assigned a UK nationality in accordance to rule 1.5 of the Determining Nationality guide.

Bank of Cyprus Holdings, has been assigned a Greece nationality under rule 1.9 of the Determining Nationality guide.

**Hut 8 Corp,** has had its nationality re-assessed under rule 1.9 of the Determining Nationality guide, Hut 8 Corp will change nationality status from Canada to the US.

**Tamboran Resources Corp** and **Life360 Inc**, have had their nationality re-assessed under rule 1.4 of the Determining Nationality guide, Tamboran Resources Corp and Life360 Inc will change nationality status from Australia to US.

**Civmec**, has had its nationality re-assessed under rule 1.4 of the Determining Nationality guide, Civmec will change nationality status from Singapore to Australia.

**Amcor**, has had its nationality re-assessed under rule 1.7 of the Determining Nationality guide, Amcor will change nationality status from Australia to US.

**Avino Silver & Gold Mines Ltd**, has had its nationality re-assessed under rule 1.4 of the Determining Nationality guide, Amcor will change nationality status from US to Canada.

## Please note:

Following a change in circumstances, **Wing Yip Food Holdings Group** (KOR, BG0D1G3) and **Anteris Technologies** (AU, BMH5Q03) continue to be assessed under rule 1.9 of the Determining Nationality guidelines. Should this result in a change to nationality it will be communicated at a subsequent scheduled nationality review.

The above table confirms nationality assignment only. Potential inclusion to the FTSE Global Equity Index Series or the FTSE UK Index Series will be subject to the security passing all other index eligibility criteria (including minimum liquidity requirements) as detailed in the respective ground rules. Index entry will be confirmed within the periodic index review notices announcing constituent changes.

However, where a company has been identified as failing the initial security eligibility criteria, such as not meeting the listing requirement for the FTSE UK Index Series or being assigned an ICB classification which is ineligible for the FTSE Global Equity Index Series, then it will be flagged as ineligible within the above table and will not be considered for index inclusion.
