### Treatment for Eid Al-Fitr Holiday - UPDATE

Further to the [FTSE Russell March 2026 Index Review - Treatment for Eid Al-Fitr Holiday](#) announcement published on 13 February 2026, FTSE Russell has updated the below questions in the supporting [Treatment of the Eid Al-Fitr holiday FAQ v1.1](#)

- **Question 1** - to reflect the updated market closure dates in the table
- **Question 3** - addition of a new question 3 which clarifies the closing prices and foreign exchange rates that will be used to implement the index changes in FTSE Russell benchmarks, effective from the open on Monday 23 March and Wednesday 25 March 2026.
- **Question 7** - addition of new question 7 covering the details explained below.

Additionally, to support index users with the implementation of the Saudi Arabia index changes effective from the open on Wednesday 25 March 2026, commencing from Monday 09 March 2026, FTSE Russell will publish a list of mandatory corporate events which are scheduled to be effective for index constituents of the FTSE Global All Cap index between Monday 23 March and Wednesday 25 March 2026. The list of mandatory corporate event types will cover those events that result in a change in the underlying index shares:

- Stock Split
- Reverse Split (consolidation)
- Bonus Issue
- Rights Issue
- Stock takeovers/mergers

The below table lists the index constituents of the FTSE Global All Cap index that are currently scheduled to have a mandatory corporate event effective between Monday 23 March and Wednesday 25 March 2026 resulting in a change in their index shares.

From Monday 09 March and until Thursday 19 March 2026, FTSE Russell will publish an updated notification if there is a change in index constituents that are scheduled to have a mandatory corporate event between Monday 23 March and Wednesday 25 March 2026. After Thursday 19 March 2026, these mandatory corporate events will be published in the T+5 tracker index product files.

Note, future pending corporate events beyond the scope of the T+5 tracker product files are available to subscribers of the Event Monitor product. Please contact your account manager or the local client services team for additional information on this product.
