

## China N-share and China S-chip: China Nationality Additions to FTSE Global Equity Index Series

Further to the 'China N-share and China S-chip Treatment Update' announcement released on 28 July 2017 ([Indicative List](#)), FTSE Russell confirms that the following securities designated as China N-shares and China S-chips will be eligible for inclusion in FTSE China indexes as part of the FTSE Global Equity Index Series (GEIS) semi-annual review effective from Monday 18 September 2017 (i.e. effective after the close on Friday, 15 September 2017).
