The above nationality changes will become effective after the close of business on Friday, 17 March 2023 (i.e. on Monday, 20 March 2023).

**Leonardo DRS**, with an incorporation & listing in US and in accordance with FTSE's Nationality rules, Leonardo DRS will change nationality status from Israel to US.

**Titan Cement International,** with failing liquidity in Belgium and in accordance with FTSE's Nationality rules, Titan Cement International will change nationality status from Belgium to Greece.

**Cenergy Holdings,** with failing liquidity in Belgium and in accordance with FTSE's Nationality rules, Cenergy Holdings will change nationality status from Belgium to Greece.

**Gran Tierra Energy Inc,** with an incorporation & listing in US and in accordance with FTSE's Nationality rules, Gran Tierra Energy Inc will change nationality status from Canada to US.

**Africa Oil Corp**, with an incorporation & listing in Canada and in accordance with FTSE's Nationality rules, Africa Oil Corp will change nationality status from Sweden to Canada.

**Please note:** The above table confirms nationality assignment only. Potential inclusion to the FTSE Global Equity Index Series or the FTSE UK Index Series will be subject to the security passing all other index eligibility criteria (including minimum liquidity requirements) as detailed in the respective ground rules. Index entry will be confirmed within the periodic index review notices announcing constituent changes.

However where a company has been identified as failing the initial security eligibility criteria, such as not meeting the premium listing requirement for the FTSE UK Index Series or being assigned an ICB classification which is ineligible for the FTSE Global Equity Index Series, then it will be flagged as ineligible within the above table and will not be considered for index inclusion.
