



# FTSE EU Climate Benchmarks, TPI Climate Transition, and Smart Sustainability Index Series

## Index Review Update

14 July 2023

FTSE Russell would like to inform users of a potential change to the September 2023 index review schedule for specific indices within the FTSE EU Climate Benchmarks Index Series, FTSE TPI Climate Transition Index Series and FTSE Smart Sustainability Index Series. These indices are listed below.

FTSE Russell proposes that the effective date for the 2023 index review for these indices will move from the open on 18 September 2023 to Q4 2023. This will allow more time between the receipt of third party data and the index review for conducting data validation. FTSE Russell will provide an update in due course on when the index reviews will be rescheduled.

In Q4 2023, the FTSE EU Climate Benchmarks indices will be reviewed, and the decarbonisation target will be set so that all indices will be back to their 7% year on year average decarbonisation rate at this point in time and going forward at each reassessment date.

Final approval of any changes will be made by the FTSE Russell Index Governance Board, with index users and other stakeholders informed via a public notification. Such notifications are published on the FTSE Russell website at [Index Announcements](#) | [FTSE Russell](#).
